### BASIC SERVICES OF FUNERAL DIRECTOR

**AND STAFF . . . . . \$4,495**

Our charge for basic services includes, but is not limited to: the services of our funeral directors and staff to respond to initial request for service, the arrangement conference, arrangement of the service, filing of necessary authorizations and permits, recording vital statistics, placement of obituary notices, staff assistance prior to and following the Celebration of Life, including coordination of service plans with cemetery, crematory and any other parties involved. Included in this charge are overhead costs relative to our facilities, professional licensing, legal and accounting, insurance, utilities, maintenance, taxes, furnishings, inventory cost and administrative expense.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial and forwarding or receiving of remains.

### PREPARATION OF THE DECEASED

**Embalming & Restorative Arts . . . . . \$590**

Except in certain cases, embalming is not required by law. Embalming may be necessary if you select arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that doesn't require you to pay for it, such as direct cremation or immediate burial or where refrigeration or the use of dry ice is available.

### Facilities, Equipment & Staff

**FACILITIES, EQUIPMENT AND STAFF FOR VIEWING/VISITATION/GATHERING . . . . . \$400**

Our services will include set-up and use of visitation/gathering area, placement of casket, urn or memorabilia. Use of equipment, display of floral arrangements, direction of visitors and general supervision. Up to 5 Hours on the day before the Celebration of

Life within our funeral home or other local facility, also includes 1 hour of visitation on day of Celebration of Life, when desired.

**Private family viewing . . . . . \$200**

A gathering up to 1 hour, family only, unless family authorizes embalming, in which case relatives and close friends may be part of the family viewing time - within our facilities only.

**FACILITIES, EQUIPMENT AND STAFF FOR CELEBRATION OF LIFE . . . . . \$625**

Our services include use of facilities, equipment & staff to coordinate the Celebration of Life at our funeral home or additional staff necessary for services at other facility.

Direct cremation includes a proportionate share of our basic services of the funeral director and staff, local transfer of deceased to our funeral home, alternative care of the deceased, assistance with necessary paperwork and placement of obituaries and the cremation process.

Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a cremation, you can use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for cremation. The containers we provide are cardboard.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.

### **\*Laying In Ceremony ..... \$1,000**

The Laying In Ceremony, at Return Home, allows families to bid their loved ones farewell in person or virtually while also adorning them with items that show love and celebrate their memory.

Natural Organic Reduction utilizes the body's own naturally occurring microbes to gently transform remains into nutrient-rich soil. The process is conducted in individual vessels and takes approximately 60 - 90 days to complete.

The resulting soil can then be returned home or donated to a Woodland property in Kent, WA to aid in the restoration of a Washington Forrest.

Return Home is the reduction/terramation center that we use. Located in Washington, they use reduction/terramation as an earth-friendly, natural alternative.
